  - EIPA (EDUCATIONAL INTERPRETER PROFICIENCY ASSESSMENT)
    CERTIFICATION WITH A SCORE OF AT LEAST 3.5 ON THE PERFORMANCE
    TEST
  - SOUTH DAKOTA LEVEL III, IV, OR V
- 3. SUBMIT PAYMENT OF THE REGISTRATION FEE IN THE AMOUNT OF:
  - \$75.00 FOR SD CERTIFIED INTERPRETERS
  - \$50 FOR NATIONALLY CERTIFIED INTERPRETERS (RID, NAD, OR EIPA)
