## Health Information Exchange (HIE)

- LTSS Specialists receive notifications each time a HOPE Waiver consumer visits the ER or is admitted, transferred, or discharged from the hospital.
- Allows for more timely intervention and collaboration with hospital discharge planners to divert individuals from nursing facility placement, when appropriate.

# Pre-Admission Screening and Resident Review (PASRR)

- Federally mandated process to prevent unnecessary nursing facility placement
- LTSS nurses carefully review the care needs of each individual presented for PASRR to ensure that their needs can't be met in a less restrictive environment.
- Enhancements to PASRR process include:
  - More frequent reviews;
  - Increased contact with NF social workers; and
  - Enhanced options planning regarding HCBS services prior to NF admissions.

#### Section Q

- Section of MDS assessment which asks about the resident's wishes and preferences in regard to returning to live in the community
- Requires the nursing facility staff to make a referral to the local LTSS office if the resident expresses a desire to return to the community

#### Section Q

- Education developed and presented collaboratively by LTSS and DOH staff in March 2017
- Webinar materials available on LTSS, DOH, SDHCA, and SDAHO websites
- Significant increase in number of Section Q referrals to local LTSS offices

## **HOPE** Waiver - Eligibility

- 65 years or older
- 18 or older with a qualifying disability (SSI/SSDI eligibility)
- Need for at least one waiver service a month

## Assistive Daily Living Services (ADLS) - Eligibility

- Must have quadriplegia defined as a substantial functional limitation in all 4 extremities;
- 18 years of age or older;
- The disability is likely to continue indefinitely;
- Must be medically stable;
- Must be able to manage and self-direct services or select a representative to manage and direct their services;
- SSI/Medicaid eligible.

- To be closely related to intellectual disability, a condition must cause impairment of general intellectual functioning or adaptive behavior similar to that of intellectual disability.
- The disability manifested itself before the individual reached age 22; and
- The disability is likely to continue indefinitely.


