

FFY 2012 Ticket to Work

Prior to January 14, 2008 when Vocational Rehabilitation consumers assigned their Ticket, it was being assigned as Outcome Payments. After this date all new cases were being assigned as Outcome-Milestone Payments.


On July 21, 2008 new regulations were issued for the Ticket to Work Program. These regulation changes made significant improvements in the Ticket to Work process, revenue potential, and new partnership options with providers. 




Ticket to Work Payments Received by FFY
